Thank you Rod. I'd like to report to you an incident that occurred yesterday during collection. The driver informed Jug if the cans (our side) 17 units are not placed 3 feet apart as required he will NOT pick up. It is not his job to have to get out and space them. We certainly can understand his frustration with this but in order to leave them down at the end of the road where we told to put them it doesn't give us enough room to place them appropriately. So 2 weeks from now we will ensure cans are 3 feet apart and string them up the road ensuring not to block owner's driveways. That then fits the criteria. I'd like to be assured then that the garbage/compost will be picked up for all owners as it will involve his backing a lot further up the road. He also told Jug that there will be no curbside pick up until the road is totally complete, no less than 2 years but possibly more.
