Re: Support for the WildSafeBC Program

We are approaching you to ask if the Town of Lake Cowichan (Lake Cowichan) would be willing to join the Municipality of North Cowichan (MNC), the Town of Ladysmith (Ladysmith) and the Cowichan Valley Regional District (CVRD) in supporting the work of WildSafeBC to reduce human-wildlife conflicts and thereby increase public safety in your community.

In 2018, the Conservation Officer Service received over 91 calls regarding wildlife in Lake Cowichan alone. This represents 26% of total calls received for the region. Nearly 55% of calls generated within Lake Cowichan were for bear conflicts. Unsecured garbage is one of the leading causes of conflicts with bears that can lead to safety concerns and the damage to property. With limited options, the Conservation Officer Service may be required to destroy black bears as relocations are often unsuccessful and can lead to poor outcomes for the bears.

In response to a plea for assistance from local conservation officers in 2015, the CVRD and Ladysmith partnered with WildSafeBC to have a WildSafeBC Community Coordinator educate residents, businesses and visitors on how to reduce human-wildlife conflicts in their communities. They were recently joined by MNC. The coordinator is funded in part by a grant from the WildSafeBC Program. This year, it is our hope that Lake Cowichan will also contribute as a partner to the program, as there are significant wildlife conflicts within the boundaries of your town.

The goal is to retain a seasonal coordinator from May to November, the months with the highest potential for human-bear and other wildlife conflicts. To date, the CVRD, Ladysmith, MNC and a two local businesses have committed to funding contributions totaling \$12,000. Your contribution will directly translate to hours that the coordinator can spend delivering the WildSafeBC program in your town. We are hopeful that Lake Cowichan will join the CVRD, Ladysmith and MNC by contributing up to \$2,000 towards the 2019 program, and in doing so, work towards reducing human-wildlife conflicts in Lake Cowichan and increasing public safety.

What is WildSafeBC?

WildSafeBC is a proven educational program that works in collaboration with communities throughout BC. Our goal is to "keep wildlife wild and communities safe". The program educates residents and visitors about the importance of managing wildlife attractants, including but not limited to proper management of curbside garbage and organics. The result is fewer wildlife conflicts, and fewer impacts to bears, cougars, deer, coyotes and other wildlife in the community. In turn, this increases human safety as well as protection of pets and livestock, and reduces the number of wild animals that need to be destroyed due to safety risks.

Education activities by the seasonal WildSafeBC Community Coordinator include our highly requested Junior Ranger Program, door-to-door outreach to residents in high conflict areas, public outreach at community events, presentations to groups of interest, clinics on the safe use of bear spray and demonstrations on how to install an electric fence.




Figure 1. Reports to the Conservation Officer Service January 1, 2018 to February 12, 2019. Bears in red denote a bear in conflict as a result of unsecured garbage.

We also reach out to the broader community and visitors via local newspapers, newsletters, radio interviews, signage and social media. We promote the use of our Wildlife Alert Reporting Program that allows residents to be informed of recent wildlife reports to the Conservation Officer Service's 24 hour hotline (see Figure 1 below).

Local Human-Wildlife Conflicts

Black bears are the most reported species in conflict with humans in Lake Cowichan. In 2018, the Conservation Officer Service received 91 calls regarding wildlife; of these, 50 calls were regarding black bears, 18 regarding elk, 8 regarding cougars and 7 regarding deer. Unsecured storage of garbage cans and dumpsters between garbage collection days, as well as unmanaged fruit trees, continue to be the main wildlife attractants and leading cause of human-bear conflict. In addition, increasing numbers of deer in urban areas draws cougars into residential areas. It is important to note that a large number of human-wildlife issues are not reported to the Conservation Officer Service, therefore it is expected that the actual number of sightings, and potential conflicts, is higher than reported.
