1. This Permit in Force

This Interim Operating Permit remains valid until <u>30 June 2019</u>, or such time as the coagulation, flocculation and filtration system is brought on-line, at which time the water supply system owner shall request the issuance of an Operating Permit that reflects the additional works, and to establish performance standards for the additional works.

Reference: Lake Cowichan Water Treatment Facility: Project Update for Island Health

In response to recent development in the construction of the Lake Cowichan Water Treatment Facility, the following letter provides an update on the schedule moving forward with a request for extension of the Interim Operating Permit until the end of the calendar year of 2019.

Substantial Completion was granted for the project on 28th February 2019, as Tritech had completed the terms of the original contract and approved change orders in accordance with the BC Builders Lien Act at that time. The addition of pH adjustment was discovered to be required as a result of jar testing during the commissioning period, and since then Stantec has been working on a design for the addition of Soda Ash to the raw water stream to bring pH within acceptable drinking water limits following the addition of flocculation/coagulant chemicals to promote settlement of suspended solids through the filtration tanks. The first design provided by Stantec to Tritech as a Contemplated Change Order (CCO) to the project was to install the pH adjustment equipment at the North Shore Raw Water Pump Station when the chlorine gas is removed – however, the structural and electrical upgrades required for the building to accept the additional equipment meant that the quoted priced exceed the Town's budget. Since that quote was received, Stantec have been working with the Town on a revised design, which now locates within the new facility in the south east corner of the building, and the Soda Ash equipment are awaiting a new quote from Tritech for the works. We are hopeful that this revised design has enough cost savings incorporated within it to bring the cost within the Town's budget.

The Town has also issued a Purchase Order for the supply of the soda ash injection equipment to Velodyne (suppliers), so the procurement of this main piece of equipment is currently underway. We are expecting shop drawings within the next week or two, and then a lead time on delivery of 10—14 weeks, which results in delivery window of the equipment to site of late September to late October.
